Revised Tender Notice

We hereby open a Tender for Hiring the school Buses for the purpose of ferrying the students to attend the classes at DAV Junior Public School, Canary Hill Road, Hazaribag as per the following terms and conditions:

1. Interested party/bus owners may send their quoted rate in a sealed envelope latest by 16.06.2025 through Registered Post or by hand only. The Buses should be of 2019 model or after 2019 Model. Please provide details for AC/Non AC buses in attached proforma on letter head.

2. Buses must fulfill Government's norms laid down by the Transport Department and Vehicle. The buses must always carry the following valid documents (in original) on the road and the same be produced on demand by the officer empowered to demand these documents to verify, under the motor vehicle Act 1988 along with other documents as displayed in e-parivahn portal whenever required :

- a. Certificate of Registration
- b. Certificate of Fitness.
- c. Certificate of Insurance.
- d. Taxation Certificate (Tax Token)
- e. Heavy Driving Licence with badge.
- f. Permit granted by the Regional Transport authority
- g. Pollution under control certificate up-to-date papers required for smooth and hassle free work in the school.

3. Hire charges will be paid to Party/Bus owners through Account Payee Cheque/RTGS only after deducting TDS as per Income-tax rule, Govt. of India.
4. Party/Bus owners will be responsible to deduct PF and ESIC contribution and also be liable to police & road accident litigation and any other legal issued etc.
5. Diesel will be provided by the transporter as per the running average mentioned in the agreement.
6. In case, the bus breaks down; the party/bus owner will make alternative arrangement at his own level for ferrying the students. If the party fails to arrange the same then the transporter will be imposed a penalty of amount equal to hiring charge per day.
7. Agreement will be applicable for 11 months w.e.f. 01-07-2025 to 30-05-2026.
8. All the buses must have wire-net cover in the windows, Bio-metric system, First-aid box, GPS and CC TV camera installed by the transporter and it must be functional during entire contract period.
9. Employees must be appointed as per the guidelines framed by the Govt. of Jharkhand state employment of local candidate in private sector rules 2022.
10. Before entering into the contract the physical verification of the buses will be done by the school.
11. Preference will be given to latest mode and better features.
